

### 4 THE POWER CE THE TRUSTEES:

- i. The Trustees shell have full power to start, to run, enlarge, abridge, takeover, transfer, delete curtail, close down all kinds of Educational Institutions as mentioned in the object clauses.
- ii. ### 5. GENERAL CLAUSES:





- 1.
