from National and International Agencies, from banks and other institutions.

- The Trustees shall also be authorised to conduct cultural vi. and benefit shows and performances tournaments and competions, exhibitions, video and film shows, lucky tips, raffle schemes, carnivels, camps, nidhies and chit finances and mutual benefit schemes to raise funds and gather supports for furthuring the objects of the Trust.

### . GENERAL CLAUSES:

- The first meeting of the Trustees shall be held within three months from the date of this Deed and shall be conveyed by any of the TWO: trustees by giving a weeks notice to all other Trustees and shall be held at such time and place as shall be specified in such notice and it shall be the first annual general meeting of the Trustees.
- 11. That a General Meeting of the Trustees shall be held once atleast in every year at which the accounts of the Trust hereby constituted shall be presented and approved by a vote of majority.
- iii. That the Accounting year of the Trust shall be from 1st April to 31st March. The accounts of Trust shall be audited every year by a Chartered Accountant or Chartered Accountants who shall be accounted by the Board of Trustees.
- iv. The Trustees aforementioned shall be adopinted for their life., time. The Managing Trustee may-co-opt such new Trustee or Trustees for such time and for such purposes as may be specified by him. The First Managing Trustee shall hold office for his life time and the Managing Trustee shall be succeeded by such person as may be nominated by him and recorded in the minutes of the Trust Board. In the absence of any such direction the remaining Trustees, after the demise of the Managing Trustee shall elect one from among themselves to the post of the Managing Trustee and shall fix such person's tenure of Office.


